5.3. Advice for firefighters

## SECTION 7: Handling and storage

#### 7.1. Precautions for safe handling

Safe handling of the gas receptacle

Only experienced and properly instructed persons should handle gases under pressure.

Keep container valve outlets clean and free from contaminants particularly oil and water. Replace valve outlet caps or plugs and container caps where supplied as soon as container
