7.1. Precautions for safe handling

Safe handling of the gas receptacle

Safe use of the product

: Gas cabinets, rooms or indoor areas where product is stored or used shall be protected by an automatic sprinkler system.

Do not breathe gas.

Avoid release of product into atmosphere.

The product must be handled in accordance with good industrial hygiene and safety procedures.

Only experienced and properly instructed persons should handle gases under pressure.

Consider pressure relief device(s) in gas installations.

Ensure the complete gas system was (or is regularily) checked for leaks before use.

Do not smoke while handling product.
