7.1. Precautions for safe handling

Safe handling of the gas receptacle

Do not breathe gas.

Avoid release of product into atmosphere.

The product must be handled in accordance with good industrial hygiene and safety procedures

Only experienced and properly instructed persons should handle gases under pressure.
