Safe handling of the gas receptacle	 Refer to supplier's container handling instructions. Do not allow backfeed into the container. Leave valve protection caps in place until the container has been secured against either a wall or bench or placed in a container stand and is ready for use. 	Unlike simple asphyxiants, carbon dioxide has the ability to cause death even when normal oxygen levels (20-21%) are maintained. 5% CO2 has been found to act synergistically to increase the toxicity of certain other gases (CO, NO2). CO2 has been shown to enhance the production of carboxy- or met-hemoglobin by these gases possibly due to carbon dioxide's stimulatory effects on the respiratory and circulatory systems.
